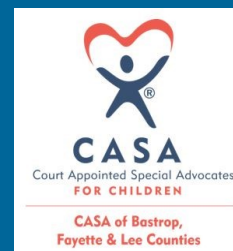

Sadie & Sam

Sadie, age 2 and Sam, age 4 were removed from their mother due to her victimization in a domestic violence case and placed in a foster home an hour away. Because of the distance, they were only able to visit with their mother once every two weeks. The CASA Volunteer advocated for them to be placed with their maternal grandparents where they could be with family and their mother could visit more regularly. Being around family helped their mother feel supported enough to leave the abusive relationship, and Sadie and Sam were reunited with her.

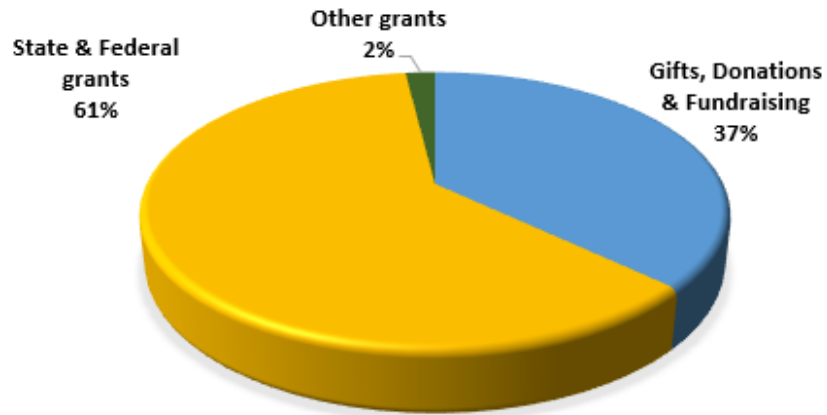
2019-2022 Strategic Planning Goals

- ◆ Create and sustain the infrastructure needed to support growth: building, staffing, technology and other resources.

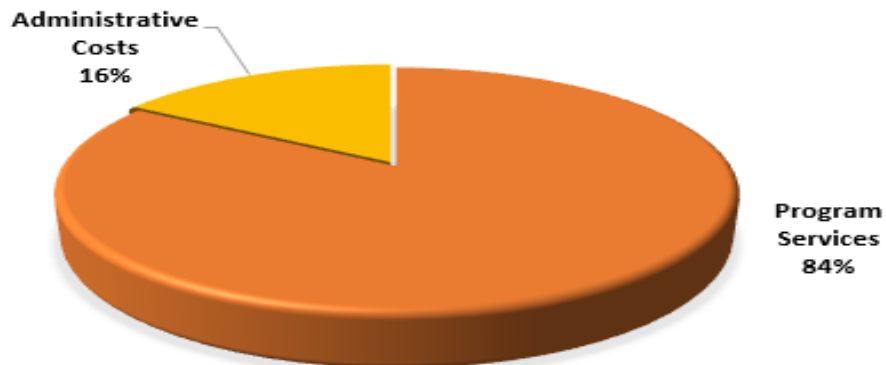
